**3:** In the event of natural calamities or unavoidable circumstances, the Tour Manger has discretionary powers to modify the route or cancel the tour.

**4:** We will make the reasonable efforts to keep the overall package of services unchanged. However, we shall not be liable to refund any amount or pay any compensation on account of any change in itinerary.

**5:** Baggage and personal belongings of the tour participant are his/her responsibility. The company shall not be liable for the loss / damage of the same.

**6:** The Company shall not be responsible and/ or liable for any damage / loss caused to the tour participant due to reasons beyond the control of the company.

**7:** Smoking and drinking alcohol is strictly prohibited during the coach/ car. Please keep the coach / cars clean to avoid discomfort to yourself and other tour participants.

**8:** If the tour participant misbehaves causing inconvenience or annoyance to any tour participant or causes damage to any property or deemed physically unfit, he/she will be asked to leave the tour immediately. The Tour Managers are authorized to do so. There will not be any compensation, whatsoever, in such cases.
